Structure, Governance and Management

Baseer Welfare International was established as a Charitable Incorporated Organisation (CIO) on 22 February 2024. It is governed by a constitution adopted on incorporation and managed by a Board of Trustees. The trustees are responsible for setting strategic direction and ensuring the charity complies with its legal and financial obligations.

Objectives and Activities

Charitable Objectives

The charity's aims are to relieve poverty, advance education, and promote health for vulnerable individuals and communities in the UK and internationally.

Public Benefit Statement

The trustees confirm they have had regard to the Charity Commission's guidance on public benefit when reviewing the charity's aims and objectives and planning its activities.

Achievements and Performance (2024–2025)

This was the first year of operation for the charity following its formal registration. Key accomplishments included:

- Raising £10,113 in unrestricted donations.
- Building early organisational capacity and community engagement.
- Laying the groundwork for future charitable programmes.

The trustees are grateful for the support of donors and volunteers during this foundational year.

Financial Review

Income

- All income in the year (£10,113) was from voluntary donations.
- No restricted income or grants were received.

Expenditure

- Total expenditure was £8,536, all related to fundraising and early-stage charity administration.
- No charitable projects were directly funded in this year, but groundwork has been completed to support delivery in the following period.



The trustees aim to maintain a reserve sufficient to cover at least 3 months of essential costs. At the end of the financial year, unrestricted reserves stood at £1,577, which is in line with early-stage expectations.

- Small Business Support
- Women Empowerment Initiatives
